NVQ Level 2 Diploma in Associate Industrial **Services Occupations - Passive Fire Protection** (via OSAT)



The Level 2 NVQ Diploma in Associated Industrial Services Occupations - Passive Fire Protection qualification has been developed for delivery in a working environment; this means you need to be employed to study this qualification. It has been designed to develop and recognise your skills, knowledge and competence so that you can work in Passive Fire Protection within the construction industry. This is ideally suited for Carpenters/Painter and Decorators or Dry Liners.

Upon completion, learners show that they have the required skills and knowledge and are competent in this specialist trade area. The NVQ is assessed through on site assessment (OSAT) by experienced and qualified staff involved in this field. The NVQ is normally needed to obtain a CSCS card. NVQs are the most respected formal qualification in the construction industry, offering proof of a candidate's practical skills and competence in construction.

The course assesses competence against the following Mandatory units:

- Conforming to General Health, Safety and Welfare in the Workplace
- Conforming to Productive Working Practices in the Workplace
- Moving, Handling and Storing Resources in the Workplace
- Erecting and dismantling access/working platforms in the Workplace

Optional Unit Group (2 units need to be completed)

- Installing Dry Cladding in the workplace
- Applying intrumescent coatings in the workplace
- Installing fire resisting ductwork systems in the workplace •
- Installing fire stopping in the workplace •
- Installing cavity barriers in the workplace
- Erecting fire resisting walls and linings in the workplace
- Erecting fire resisting ceiling systems in the workplace
- Applying non reactive spray coatings in the workplace
- Installing fire resisting timber doorsets in the workplace

Assessment

Learners are required to develop a portfolio of evidence that demonstrates competence in each area supported by an experienced OSAT Supervisor from the Construction sector. There will normally be a minimum of 2-4 visits on site by your allocated OSAT Supervisor. The initial visit will assess a learner's suitability for the qualification through a Q & A profiling exercise.

Evidence will be gathered using witness statements, video, photographic evidence, written evidence and professional discussion. On successful completion of the course you will receive a NVQ Level 2 Diploma in Associate Industrial Services Occupations – Passive Fire Protection

Awarding body

This qualification is approved through GQA.

Entry Requirements

Learners must be experienced and practicing workers in the Construction sector. It is expected that learners will have a minimum of 2 years experience in a relevant trade.

Length

Between 3 and 12 months depending on experience and evidence provided through site visits.

Related Courses

This programme is part of a suite of qualifications including the L2 and L3 Interior Systems, Sie Carpentry and Decorative Finishing.

Grant

Additional funding may be available to support this qualification through a number of schemes. Eligibility criteria applies. Please contact 01554 748344 for more details. CITB Achievement grants of £400 are available for levy payers plus uplift. Scope and eligibility will need to be assessed prior to registration.

CSCS Card

Successful learners can obtain the Blue Skilled Worker Card. In all cases applicants must pass the appropriate CITB Health, Safety and Environment test.
