

NVQ Level 6 Diploma in Construction Site Management (via OSAT)



The Construction Site Management NVQ Level 6 Diploma is designed for experienced construction personnel who carry out the function of Construction Site Management. It will enable them to gain a recognised qualification to prove competence. The Construction Site Management Units provide an overview of all aspects of the job role.

The learner will need to demonstrate:

- Developing and Maintaining Good Occupational Working Relationships in the Workplace
- Allocating Work and Checking People's Performance in the Workplace
- Establishing, Implementing and Maintaining Systems for Managing Health, Safety and Welfare in the Workplace
- Evaluating and Selecting Work Methods to Meet Project or Operational Requirements in the Workplace
- Monitoring Construction Related Project Activities in the Workplace
- Controlling Project Progress against Agreed Quality Standards in the Workplace
- Controlling Project Progress against Agreed Programmes in the Workplace
- Managing Personal Development in a Construction related Workplace
- Identifying and Enabling Learning Opportunities for Given Work Teams in the Workplace
- Establishing, Controlling and Monitoring Environmental Factors and Sustainability in the Workplace
- Planning the Preparation of the Site for the Project or Operation in the Workplace
- Ensuring that Work Activities Resources Meet Project Work Requirements in the Workplace
- Identifying, Allocating and Planning the Deployment and Use of plant, Equipment or Machinery in the Workplace
- Organising, Controlling and Monitoring Supplies of Materials in the Workplace
- Establishing and Monitoring Communication Systems and Organisational Procedures in the Workplace
- Establishing Project Dimensional Control Criteria in the Workplace
- Controlling Project Quantities and Costs in the Workplace
- Evaluating Feedback information and Recommending Improvements in the Workplace



Assessment

Learners are required to develop a portfolio of evidence that demonstrates competence in each area supported by an experienced OSAT Supervisor from the Construction sector. There will normally be a minimum of 4-8 visits on site by your allocated OSAT Supervisor. The initial visit will assess a learners suitability for the qualification through a Q & A profiling exercise.

Evidence will be gathered using witness statements, photographic evidence, written evidence and professional discussion. On successful completion of the course you will receive a Level 6 NVQ Diploma in Construction Site Management.

Awarding body

This qualification is approved through City & Guilds.

Entry Requirements

Learners must be experienced and practicing workers in the Construction sector. It is expected that learners will have a minimum of 2 years experience as a Site Manager.

Length

Between 12 and 18 months depending on experience and evidence provided through site visits.

Related Courses

This programme is part of a suite of construction supervisory qualifications including the NVQ Level 3 in Occupational Work Supervision.

Grant
